EXECUTED BUY-BACK PROGRAM

Luxembourg - July 31st, 2023 – d'Amico International Shipping S.A. ("DIS" or the "Company") announces today that during the period between July 24th and July 28th, 2023, n. 139,000 own shares (representing 0.112% of the outstanding share capital of the Company) were repurchased on the regulated market managed by Borsa Italiana S.p.A. at the average price of Euro 3.5916 and for a total consideration of Euro 499,237.20.

As at July 28th, 2023, d'Amico International Shipping S.A. holds nr. 2,529,855 own shares, representing 2.04% of its outstanding share capital.

The transactions were made and coordinated by an independent equity broker duly engaged for this purpose, Equita SIM S.p.A., in compliance with the Board of Directors resolution of June 14th, 2023, and under the authorization to purchase own shares approved by DIS Shareholders' extraordinary meeting held on June 13th, 2023 (as reminded by means of a press release issued on June 14th, 2023).
